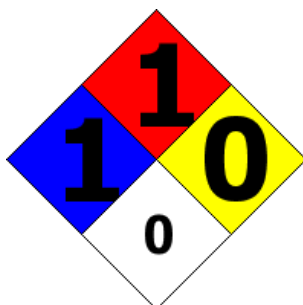

Description of first aid measures
