**After swallowing:** Rinse mouth thoroughly. Do not induce vomiting. Have exposed individual drink sips of water. Seek medical attention if irritation, discomfort or vomiting persists.

#### Most important symptoms and effects, both acute and delayed:

Headache, Shortness of breath. Irritation/burns, all routes of exposure. May cause severe burns, blindness and/or permanent damage.
