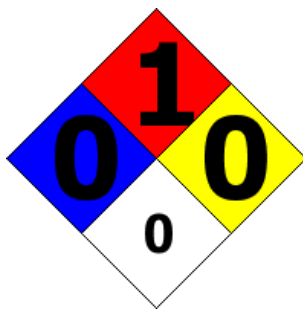

SECTION 4 : First aid measures

Description of first aid measures

After inhalation: Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen. Give artificial respiration if necessary. DO NOT use mouth-to-mouth resuscitation.

After skin contact: Wash affected area with soap and water. Rinse/flush exposed skin gently using water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

After eye contact: Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Seek medical attention if irritation persists or if concerned.

Suitable extinguishing agents: If in laboratory setting, follow laboratory fire suppression procedures. Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

Advice for firefighters:

Protective equipment: Use NIOSH-approved respiratory protection/breathing apparatus.

Additional information (precautions): Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Use spark-proof tools and explosion-proof equipment.

recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Clean up spills immediately observing requirements in section 8.

SECTION 7 : Handling and storage

Precautions for safe handling:

Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

Conditions for safe storage, including any incompatibilities:

Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Store with like hazards
