Methods for Containment and Clean Up

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Wear self-contained breathing apparatus and protective suit. Do not expose spill to water. Do not let this chemical enter the environment.

7. Handling and storage

Handling

Do not breathe dust. Do not breathe vapors or spray mist. Do not get in eyes, on skin, or on clothing. Do not ingest. Use only in area provided with appropriate exhaust ventilation. Do not allow contact with water. Contents may develop pressure upon prolonged storage. Do not allow contact with water because of violent reaction. Keep under nitrogen.

Storage

Keep in a dry, cool and well-ventilated place. Keep container tightly closed. Protect from moisture. Corrosives area. Long-term storage is not recommended. Keep under nitrogen.
