Personal Precautions

Wear self-contained breathing apparatus and protective suit. Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid dust formation. Remove all sources of ignition. Do not get in eyes, on skin, or on clothing.

Environmental Precautions
