Methods for Containment and Clean Up Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Wear self-contained breathing apparatus and protective suit. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Do not let this chemical enter the environment.

7. Handling and Storage
