7. Handling and storage

Handling

Use only under a chemical fume hood. Wear personal protective equipment/face protection. Keep away from open flames, hot surfaces and sources of ignition. Take precautionary measures against static discharges. If peroxide formation is suspected, do not open or move container. Use spark-proof tools and explosion-proof equipment. Avoid contact with skin, eyes or clothing. Avoid ingestion and inhalation. Do not allow contact with water. Use spark-proof tools and explosion-proof equipment. Use only non-sparking tools. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded.

Storage.
