6. Accidental release measures

7. Handling and storage

Handling

Shelf life 12 months. May form explosive peroxides on prolonged storage. Containers should be dated when opened and tested periodically for the presence of peroxides. Should crystals form in a peroxidizable liquid, peroxidation may have occurred and the product should be considered extremely dangerous.
