6. Accidental release measures

Personal Precautions	Use personal protective equipment as required. Remove all sources of ignition. Take precautionary measures against static discharges. Ensure adequate ventilation.

Methods for Containment and Clean Up	Soak up with inert absorbent material. Keep in suitable, closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

7. Handling and storage

Handling	Wear personal protective equipment/face protection. Do not get in eyes, on skin, or on clothing. Avoid ingestion and inhalation. Keep away from open flames, hot surfaces and sources of ignition. Use only non-sparking tools. Use spark-proof tools and explosion-proof equipment. Take precautionary measures against static discharges. Wash hands before breaks and immediately after handling the product. If peroxide formation is suspected, do not open or move container. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded.
Storage	Keep containers tightly closed in a dry, cool and well-ventilated place. Keep away from

heat, sparks and flame. Refrigerator/flammables. May form explosive peroxides on prolonged storage. Containers should be dated when opened and tested periodically for the presence of peroxides. Should crystals form in a peroxidizable liquid, peroxidation may have occurred and the product should be considered extremely dangerous. In this instance, the container should only be opened remotely by professionals.
