Methods for Containment and Clean Up Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Do not let this chemical enter the environment.

7. Handling and storage

Handling Ensure adequate ventilation. Wear personal protective equipment/face protection. Avoid contact with skin and eyes. Do not breathe mist/vapors/spray. Take precautionary measures against static discharges. Do not ingest. If swallowed then seek immediate medical assistance. Use spark-proof tools and explosion-proof equipment. Use only non-sparking tools. If peroxide formation is suspected, do not open or move container. Keep away from open flames, hot surfaces and sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded.

Storage. Refrigerator/flammables. Keep in a dry, cool and well-ventilated place. Keep container tightly closed. Keep away from heat, sparks and flame. Containers should be dated when opened and tested periodically for the presence of peroxides. Should crystals form in a peroxidizable liquid, peroxidation may have occurred and the product should be considered extremely dangerous.
