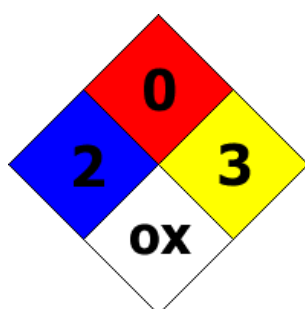

## Ammonium Nitrate, ACS

Wash skin thoroughly after handling.

##### After inhalation:

### After swallowing:

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Seek medical attention if irritation, discomfort, or vomiting persists.

### Most important symptoms and effects, both acute and delayed:

Irritation. Shortness of breath. Headache. Nausea. Dizziness. Inhalation - May cause respiratory irritation. Stomach - Irregularities - Based on Human Evidence. Gastrointestinal disturbance, Blood disorders.
