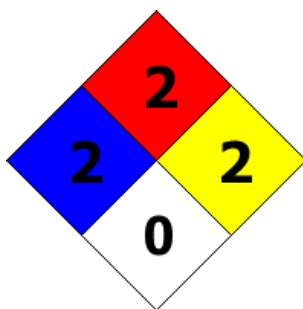

Description of first aid measures

After inhalation:

Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

After skin contact:

Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

After eye contact:

Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Seek medical attention if irritation persists or if concerned.

After swallowing:

Rinse mouth thoroughly. Do not induce vomiting. Have exposed individual drink sips of water. Seek medical attention if irritation, discomfort or vomiting persists. Never give anything by mouth to an unconscious person.

Most important symptoms and effects, both acute and delayed:

SECTION 5: Firefighting measures

Extinguishing media

Suitable extinguishing agents:

Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Water spray may cause frothing. For large fires, use water spray, fog or regular foam. Contact professional fire-fighters immediately. For small fires, use dry chemical, carbon dioxide, sand, earth, water spray or regular foam. Cool containers with flooding quantities of water until well after fire is out.

Unsuitable extinguishing agents: None

Special hazards arising from the substance or mixture:

Thermal decomposition can lead to release of irritating gases and vapors. sulfur oxides. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Dust can be an explosion hazard when exposed to heat or flame. This material in sufficient quantity and reduced particle size is capable of creating a dust explosion. Flammable solid. May burn rapidly with flare burning effect. May re-ignite after fire is extinguished.

Advice for firefighters:

Protective equipment:

Use NIOSH-approved respiratory protection/breathing apparatus. Evacuate area and fight fire from a safe distance. As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear.

Additional information (precautions):

Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Use spark-proof tools and explosion-proof equipment. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Avoid inhaling gases, fumes, dust, mist, vapor, and aerosols. Avoid contact with skin, eyes, and clothing.

Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Use spark-proof tools and explosion-proof equipment. Ensure that air-handling systems are operational. Ensure adequate ventilation.

Environmental precautions:

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13. Should not be released into environment.

Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Refer to Section 8. Always obey local regulations. Vacuum or sweep up material and place into a suitable disposal container. Clean up spills immediately, observing precautions in the Protective Equipment section. Scoop up with a nonsparking tool, then place into a suitable container for disposal. Avoid generating dusty conditions. Remove all sources of ignition. Provide ventilation. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.

handling. Remove contaminated clothing and wash before reuse. Minimize dust generation and accumulation. May form flammable dust-air mixtures. Avoid contact with eyes, skin, and clothing. Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep container tightly closed. Keep away from heat, sparks and flame. Use with adequate ventilation. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with eyes, skin, and clothing.
